

**Master of Science in Education
Teacher Education – Educational Technology**

You have six (6) years in which to complete your master's degree from the day of acceptance into the Graduate Program. Only two (2) workshops, for a total of 6 s.h. may count towards graduation (if applicable) as electives. Workshops **DO NOT** substitute for required courses. See Chairperson or Advisor for acceptable substitutions. Also see graduate catalog for course prerequisites and other important information. **All seminars and workshops must be approved IN ADVANCE by the program advisor.**

Only certain Upper Division undergraduate courses may be taken for graduate credit. Those that are in this category are listed in the courses section of the Youngstown State University Bulletin Graduate Edition. **To earn graduate credit in an Upper Division course, the student must have been admitted to the Graduate School at the time the course is taken.** Courses taken for undergraduate credit cannot count toward fulfillment of a graduate degree. Consult the Chairperson of Teacher Education for acceptable substitutions.
